



Requirements

To be eligible to participate in the Kute Kids contest, participants must be between the ages of newborn to four years of age on the first day of the fair, and must reside in either Worcester, Somerset, Wicomico, or Accomack County.

A 5 x 7 color photograph of the participant along with completed registration form (see below) must be sent to: Kute Kids Contest, c/o Lisa Taylor, 4215 Payne Road, Pocomoke, MD 21851 no later than July 15, 2010 for inclusion in this year's contest.

The submitted photograph can be a professional studio picture or a snapshot but should include only the participant entering the contest (no other siblings please). The content of the submitted picture must be appropriate for public display. Any photographs submitted that do not meet this criteria will be returned to the owner and not entered in the Great Pocomoke Fair Kute Kids Contest.

Guidelines for the Contest

All entered photographs will be on display for voting at Eastern Shore Bowling Lanes, 1834 Market Street, Pocomoke, MD, from July 17th through August 26th and in the Grand Stand building at the Great Pocomoke Fair, August 26th through 28th. The participant entries gaining the highest monetary value and the second highest monetary value will be awarded the People's Choice Winner award and People's Choice Runner Up Winner award respectively. In the event of a tie, the final decision will be made by the event coordinator.

Announcement of Winners

A presentation of awards will be held at the Grand Stand on the last day of the fair, Saturday, August 28, 2010. All participants are asked to be at the Grand Stand no later than 4:15pm. Please check in your child at the registration desk inside the Grand Stand building so that we know you have arrived. The presentation of awards will begin at 4:30pm following the conclusion of the previous event.

Prizes, Trophies, & Awards

All participants in attendance at the presentation will receive a "goody" bag filled with toys, restaurant certificates, books, candy, etc.

People's Choice Winner & People's Choice Runner Up Winner

Additionally, the People's Choice Winner and the People's Choice Runner Up Winner will receive a trophy for his/her achievement, a free sitting and 8x10 portrait from Robert Huey Photography, and a \$50 savings bond.

The People's Choice Winner and People's Choice Runner Up Winner must be present at the presentation ceremony on Saturday, August 28, 2010 to receive their awards. In the event that the actual winner(s) are not present, the title, trophy, savings bond, portrait package, and all other prizes will be given to the attending participant entry with the next highest monetary value collection.
